Along with plan review, report writing, presentation skills, lighting, planning & zoning, and behavioral management. This course will include a CPTED field assessment.

Earning the CPTED Professional Designation allows you to develop advanced skill sets in the area of Crime Prevention Through Environmental Design and professional recognition from your peers and other professionals. The CPD demonstrates your knowledge and competence and brings notable credentials to your resume.
